

## 2026 OSCAR RED CARPET FAN EXPERIENCE SWEEPSTAKES - OFFICIAL RULES

### NO PURCHASE NECESSARY

#### I. NAME OF SPONSOR(S)

KABC-TV, ABC Holding Company Inc. (hereinafter referred to as “**Sponsor**”), 500 Circle Seven Drive, Glendale, CA 91201.

#### II. ELIGIBILITY

The “2026 Oscar Red Carpet Fan Experience” Sweepstakes (the “**Sweepstakes**”) is open only to legal United States residents who reside in the Designated Market Area (“**DMA**”) of KABC-TV, as determined by Nielsen Media Research Services, and who are at least eighteen (18) years of age or older. The DMA of KABC-TV covers the following counties: Inyo, Kern County-East, Los Angeles, Orange, Riverside County-East, Riverside County-West, San Bernardino, Ventura, and Esmeralda counties in the State of California.

Any individuals (including, but not limited to, employees, consultants, independent contractors, and interns) who have, within the past six (6) months, performed services for Sponsor, American Broadcasting Companies, Inc., the Academy of Motion Picture Arts and Sciences (“**A.M.P.A.S.**”), other television and radio stations in the greater Los Angeles area, or any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Sweepstakes or supplying a prize, and/or their respective parent, subsidiary, affiliated and successor companies, and immediate family and household members of such individuals, and any person who, within the past ninety (90) days, has been awarded a prize in any sweepstakes conducted by Sponsor, are not eligible to enter or win (subject to the conditions stated below). “Immediate family members” shall mean parents, stepparents, children, stepchildren, siblings, stepsiblings, or spouses. “Household members” shall mean people who share the same residence at least three (3) months a year.

#### III. HOW AND WHEN TO ENTER

Watch Eyewitness News each weekday at 4:00 p.m. Pacific Time (“**PT**”) beginning February 23, 2026, through February 26, 2026 (“**Sweepstakes Period**”). Each day, there will be one (1) new “SECRET CODE” for this Sweepstakes that appears during the broadcast.

Once you have the Secret Code, each weekday during the Sweepstakes Period from 4:00 p.m. PT to 8:00 p.m. PT you may enter the “SECRET CODE” corresponding to that day by navigating the Internet to <http://www.abc7.com/promotions> (“**Website**”), clicking on the Sweepstakes-themed image and then clicking on the link to the Sweepstakes entry form. To submit an official Sweepstakes entry, complete the Sweepstakes entry form and enter the correct “SECRET CODE.” CLICK THE CHECK BOX SIGNIFYING THAT YOU HAVE READ AND AGREE TO THESE OFFICIAL RULES. IF YOU DO NOT CHECK THE BOX INDICATING YOUR CONFIRMATION OF AND AGREEMENT TO THE ABOVE, YOU WILL NOT BE ENTERED IN THE SWEEPSTAKES AND CANNOT WIN THE PRIZE. Entrants will receive one (1) entry into the Sweepstakes drawing with the submission of a correctly spelled “SECRET CODE.” For example, if hypothetically the “SECRET CODE” is “cat” the entrant has to submit “cat” (correctly spelled, capitalization need not be exact).

Limit one (1) Sweepstakes entry via the method listed above (each an “**Entry**” and collectively referred to herein as “**Entries**”) per person per Secret Code during the Sweepstakes Period, regardless of how many Member accounts a person may have (as further described below). Entries remain the property of Sponsor and will not be returned or acknowledged. One (1) Entry per person throughout the duration of the Sweepstakes Period.

To enter the Sweepstakes, you must be a registered member of One-ID (“**Member**”).

**Existing Member:** As a Member, you may enter the Sweepstakes by logging into One-ID through the Website with your user name or email address and password and following the entry instructions. If you login to your Member account using Facebook, you will be asked to allow Facebook’s “Basic App Permissions,” which is required in order to login to your Member account and participate in the Sweepstakes.

**Non-Member:** If you are not a Member, you may become a Member free of charge by visiting the Website and registering by providing the requested information on the registration form through the “sign up” or similar section on the Website. By creating

a Member account, you acknowledge your agreement to the Terms of Use (available at <http://disneytermsofuse.com>). Upon becoming a Member and meeting eligibility requirements, you may enter the Sweepstakes by following the instructions.

By clicking the "Continue" button to continue with your Entry (as described below), you confirm that you meet the eligibility requirements of this Sweepstakes and agree to these Sweepstakes Official Rules. During the registration and entry process, you may be asked to consent to receive promotional and marketing emails from ABC and/or other members of the Walt Disney family of companies or the prize provider. Sponsor is not responsible for failed, partial or garbled computer transmissions, or for technical failures of any kind, including, but not limited to, electronic malfunction or damage of any network, hardware or software. If for any reason the Sweepstakes is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or other causes that corrupt or affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes, Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Sweepstakes. No responsibility is assumed for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, Entries; or any problems or technical malfunctions of any telephone network or lines, computer online systems, servers, or providers, computer equipment, software, failure of any email or electronic Entry to be received on account of technical problems or traffic congestion on the Internet or Website, or any combination thereof, including any injury or damage to entrant's or any other person's computer related to or resulting from participation in or downloading any materials from this Sweepstakes. Except as otherwise contemplated by these Official Rules, and to the extent entrants may otherwise elect at the time of Entry, information provided by you for these Sweepstakes is subject to Sponsor's privacy policy.

#### **IV. HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED**

Eight (8) potential winners will be selected via a random drawing from among all eligible Entries received during the Sweepstakes Period. Names will be drawn on or about February 26, 2026. Potential winners will be notified on or around the date of selection by telephone or email at the email address or phone number listed in their Member account profiles. Odds of winning depend on the total number of valid Entries received.

Final determination of the winners is always conditional on verification of eligibility and compliance with these Official Rules and procedures. Failure to respond to the initial verification phone call and/or email within twelve (12) hours after initial notification to a potential winner or return of the email notification as undeliverable after two (2) attempts may result in disqualification and award of the prize to an alternate winner. Potential winner will may required to complete, sign and return within one (1) business day of transmission, an Affidavit of Eligibility, Release and Indemnification, and a Publicity Release where allowed by law, and any other documentation required by Sponsor (collectively, "**Verification Documents**"). If a potential winner does not respond to the initial notification within twelve (12) hours as set forth above, if Verification Documents are not returned to Sponsor within the specified time period, if a potential winner cannot attend any programming connected with the Sweepstakes on the specified date, if any prize notification or prize is returned as non-deliverable, if a potential winner is found to be ineligible or otherwise not in compliance with these Official Rules, or if a potential winner cannot or does not accept the prize for any reason, prize may be forfeited and potential winner may be disqualified without compensation of any kind and an alternate winner may be selected in a random drawing (time permitting) from remaining eligible entries received.

In the event of any dispute concerning the identity of any entrant, the Entry will be deemed submitted by the natural person who is the authorized holder of the email listed in the Member account. "Authorized account holder" is defined as the natural person who is assigned to an email address by an Internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

#### **V. PRIZE**

Eight (8) Prizes are available. Each Prize consists of two (2) spots for the winner and one (1) guest to the Oscar Red Carpet to be held on March 15, 2026 at the Dolby Theater in Hollywood (collectively, the "Prize"). INCLUDES ACCESS TO THE FAN AREA AT OSCARS ARRIVALS; TICKETS TO ACADEMY AWARDS® CEREMONY ITSELF ARE NOT INCLUDED.

There will be no viewing of the Oscars telecast. Arrival time will be at or around 10:30 am PST. Guests will be required to stand throughout the entire event. Lunch will be provided. Winner and their guest must dress in FORMAL – BLACK OR DARK NAVY attire. Dark suits, gowns, skirts below the knees, dress pants, jumpsuits, etc. More information will be provided to the confirmed winner.

There is no retail value associated with the Prize.

All expenses not specifically provided for herein, including transportation to and from the venue, parking, concessions and merchandise (if applicable), are winner's sole responsibility. Some restrictions may apply. Winners and their guests agree to abide by all rules, terms, conditions, restrictions and entry requirements imposed by the venue, including, but not limited to, any applicable social distancing, proof of vaccination, and masking requirements. Failing to abide by these rules, or exhibiting behavior that is deemed to be inappropriate, threatening, obnoxious, unruly, or otherwise prohibited by Sponsor or the venue shall result in possible denial of entry to the Prize-related event or ejection.

to, acts of God or civil disturbance that render it impractical or impossible to complete or fulfill the Sweepstakes as originally planned.
