"A COMPLETE UNKNOWN" ON THE RED CARPET SWEEPSTAKES - OFFICIAL RULES

NO PURCHASE NECESSARY.

I. NAME OF SPONSOR(S)

KABC-TV, ABC Holding Company Inc. (hereinafter referred to as "**Sponsor**"), 500 Circle Seven Drive, Glendale, CA 91201.

II. ELIGIBILITY

"A COMPLETE UNKNOWN" On The Red Carpet Sweepstakes (the "Sweepstakes") is open to legal residents of the fifty (50) United States and the District of Columbia who are eighteen (18) years of age or older at the time of entry.

To enter the Sweepstakes, you'll first need to become a registered user of www.lnstagram.com ("Instagram") or log into your Instagram account. If you do not have an account, go to www.lnstagram.com to create one. Instagram accounts are free. By submitting your information and creating an Instagram account, you agree to the Instagram Terms of Use and Privacy Notice. If you do not agree to such Terms of Use and Privacy Notice, you cannot create an Instagram account, or participate in this Sweepstakes. Additionally, to enter, your account must be set to public.

Entrant agrees that Released Parties (as defined below) are not responsible for any unauthorized use of entries by third parties. Released Parties do not guarantee the posting of any entry and may remove any posted entry at any time.

Neither Sponsor nor On The Red Carpet can provide any technical support, and accept no responsibility for ensuring the receipt or successful submission of your Entry. Mass Entries or Entries generated by a script, macro or use of automated methods will be disqualified. Sponsor is not responsible for failed, partial or garbled computer transmissions, or for technical failures of any kind, including, but not limited to, electronic malfunction or damage of any network, hardware or software. IV. HOW AND WHEN WINNER WILL BE SELECTED AND NOTIFIED

At the conclusion of the Entry Period, forty (40) potential winners will be selected in a random drawing from among all eligible Entries received. Potential winners will be notified on or around the date of selection by Instagram direct message and/or a comment on their Entry.

Odds of winning depend on the total number of valid Entries received. Limit one (1) prize per person and only one (1) person per household can win.

Final determination of the winners is always conditional on verification of eligibility and compliance with these Official Rules and procedures.

Failure to respond within twenty-four (24) hours after initial notification message to a potential winner or return of the notification as undeliverable after two (2) attempts may result in disqualification and award of the prize to an alternate winner.
