

DESTINATION: WALT DISNEY WORLD® SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

I. **NAME OF SPONSOR.** KABC Television, LLC, licensee of KABC-TV (hereinafter referred to as “**Sponsor**”), 500 Circle Seven Drive, Glendale, CA 91201.

II. **ELIGIBILITY.** The Destination: *Walt Disney World*® Sweepstakes (the “**Sweepstakes**”) is open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years of age and the age of majority in their state of legal residence, whichever is older, at the time of entry.

Any individuals (including, but not limited to, employees, consultants, independent contractors, and interns) who have, within the past six (6) months, performed services for Sponsor, Disney Destinations, LLC (“**Disney**”), or any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Sweepstakes or supplying a prize, and/or their respective parent, subsidiary, affiliated and successor companies, and immediate family and household members of such individuals, and any person who, within the past ninety (90) days, has been awarded a prize in any sweepstakes conducted by Sponsor, are not eligible to enter or win. "Immediate family members" shall mean parents, stepparents, children, stepchildren, siblings, stepsiblings, or spouses. "Household members" shall mean people who share the same residence at least three (3) months a year.

III. **HOW AND WHEN TO ENTER.** Viewers should watch the program entitled “Destination: Walt Disney World” on September 27 – October 5, 2025 on select ABC stations and streaming on <https://abc7.com/destination/> (the “**Website**”) to get the “SECRET CODE”. Check local listings for program times in your area, or stream the show on the Website beginning on September 27, 2025. Starting at 11:59 am Pacific Time (“**PT**”) on Friday, September 26, 2025 and ending at 11:59 pm PT on Tuesday, November 4, 2025 (“**Entry Period**”), entrants may enter the “SECRET CODE” by navigating the Internet to the Website to submit an entry. To submit an official Sweepstakes entry, complete the Sweepstakes entry form and enter the correct “SECRET CODE.” CLICK THE CHECK BOX SIGNIFYING THAT YOU HAVE READ AND AGREE TO THESE OFFICIAL RULES. IF YOU DO NOT CHECK THE BOX INDICATING YOUR CONFIRMATION OF AND AGREEMENT TO THE ABOVE, YOU WILL NOT BE ENTERED IN THE SWEEPSTAKES AND CANNOT WIN THE PRIZE. Entrants will receive one (1) entry into the Sweepstakes drawing with the submission of a correctly spelled “SECRET CODE.” For example, if hypothetically the “SECRET CODE” is “cat” the entrant has to submit “cat” (correctly spelled, capitalization need not be exact).

Limit one (1) total Sweepstakes entry (“Entry”) via the method listed above per person during the Entry Period, regardless of how many email addresses or Member accounts a person may have. Entries must be received during the Entry Period. Entries remain the property of Sponsor and will not be returned or acknowledged. For purposes of these Official Rules, all times and days are Pacific Time. Sponsor’s computer is the official time-keeping device for the Sweepstakes.

To enter the Sweepstakes, you must be a registered member of the Website (“**Member**”).

Existing Member: As a Member, you may enter the Sweepstakes by logging into One-ID through the Website with your username or email address and password and following the entry instructions. If

you login to your Member account using Facebook, you will be asked to allow Facebook's "Basic App Permissions," which is required in order to login to your Member account and participate in the Sweepstakes.

Non-Member: If you are not a Member, you may become a Member free of charge by visiting the Website and registering by providing the requested information on the registration form through the "sign up" or similar section on the Website. By creating a Member account, you acknowledge your agreement to the Terms of Use (available at <http://disneytermsofuse.com>). Upon becoming a Member and meeting eligibility requirements, you may enter the Sweepstakes by following the instructions.

By clicking the "Continue" button to continue with your Entry (as described below), you confirm that you meet the eligibility requirements of this Sweepstakes and agree to these Sweepstakes Official Rules. During the registration and entry process, you may be asked to consent to receive promotional and marketing emails from ABC and/or other members of the Walt Disney family of companies or the Prize Provider. Consenting to receive promotional, marketing or reminder emails is optional, does not have to be agreed to in order to be eligible to enter the Sweepstakes and does not improve your chances of winning. In the event you do consent to receive these emails, the use of such emails shall be subject to Sponsor's Privacy Policy, available at www.disneyprivacycenter.com.

Neither Sponsor nor the Website can provide any technical support, and accept no responsibility for ensuring the receipt or successful submission of your Entry. Mass Entries or Entries generated by a script, macro or use of automated methods will be disqualified. Sponsor is not responsible for failed, partial or garbled computer transmissions, or for technical failures of any kind, including, but not limited to, electronic malfunction or damage of any network, hardware or software. If for any reason the Sweepstakes is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or other causes that corrupt or affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes, Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Sweepstakes. No responsibility is assumed for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, Entries; or any problems or technical malfunctions of any telephone network or lines, computer online systems, servers, or providers, computer equipment, software, failure of any email or electronic Entry to be received on account of technical problems or traffic congestion on the Internet or at any website, or any combination thereof, including any injury or damage to entrant's or any other person's computer related to or resulting from participation in or downloading any materials from this Sweepstakes. Except as otherwise contemplated by these Official Rules, and to the extent entrants may otherwise elect at the time of Entry, information provided by you for these Sweepstakes is subject to Sponsor's privacy policy.

- IV. **HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED.** On or about Friday, November 7, 2025 one (1) potential winner will be selected via a random drawing from among all eligible entries received. Potential winner will be notified on or around the date of selection by telephone or email at the email address or phone number listed in their Member account profiles. **Odds of winning depend on the total number of valid Entries received.**

Final determination of the winner is always conditional on verification of eligibility and compliance with these Official Rules and procedures. Failure to respond within forty-eight (48) hours after initial

notification message to a potential winner or return of the notification as undeliverable after two (2) attempts may result in disqualification and award of the prize to an alternate winner. Potential winner will be required to complete, sign and return within three (3) business days of transmission, an Affidavit of Eligibility, Release and Indemnification, and a Publicity Release where allowed by law, W-9 Form, if applicable and any other documentation required by Sponsor (collectively, **“Verification Documents”**). If potential winner does not respond to the initial notification within forty-eight (48) hours as set forth above, if Verification Documents are not returned to Sponsor within the specified time period, if the potential winner cannot attend any travel dates connected with the Sweepstakes on the specified date (if applicable), if any prize notification or prize is returned as non-deliverable, if a potential winner is found to be ineligible or otherwise not in compliance with these Official Rules, or if a potential winner cannot or does not accept the prize for any reason, prize may be forfeited and such potential winner may be disqualified without compensation of any kind and an alternate winner may be selected in a random drawing (time permitting) from remaining eligible Entries received.

In the event of any dispute concerning the identity of any entrant, the Entry will be deemed submitted by the natural person who is the authorized holder of the email address listed in the Member account. “Authorized account holder” is defined as the natural person who is assigned to an email address by an Internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

V. **PRIZE.** One (1) prize (**“Prize”**) is available. The Prize consists of a three (3)-night *Walt Disney World*[®] Resort vacation package for the winner and up to three (3) persons (**“Vacation Package”**) that consists of the following and is subject to the following conditions:

- Up to four (4) roundtrip coach fares (with possible layovers) between the major U.S. gateway airport closest to the winner’s residence (**“Departure Airport”**) and Orlando International Airport in Orlando, FL (**“Arrival Airport”**).
- One (1) standard room with a maximum occupancy of four (4) persons at a *Walt Disney World*[®] Resort hotel (hotel selection at the discretion of Disney) for three (3) nights.
- Ground transportation for up to four (4) persons or voucher(s) for local transportation from the Arrival Airport to the hotel and from the hotel to the Arrival Airport (at the discretion of Disney).
- Four (4) standard three (3)-day *Walt Disney World*[®] Theme Park tickets with Park Hopper[®] option (each, a **“Ticket”**). **Each Ticket will expire on October 15, 2026.**

The approximate retail value (“ARV”) of the Prize is \$5,000.00. The actual value of the Vacation Package may vary depending on point of departure and fluctuations of rates and fares (if applicable). If the actual value of the Vacation Package is less than stated ARV, the difference will not be awarded.

Additional Prize Restrictions:

- Vacation Package must be completed prior to **October 15, 2026**. The Prize winner and up to three (3) guests (each a **“Guest”**; collectively **“Guests”** and together with the winner, the **“Group”**) must travel together on the same itinerary, and air transportation must be round-trip from/to the same Departure Airport/Arrival Airport, as chosen by Disney.
- Vacation Package fulfillment and travel are subject to certain restrictions, air travel/flight availability, and certain hotel/room availability at the Resort. The Vacation Package must be booked through a travel agent as designated by Disney at least forty-five (45) days prior to

Airline tickets are non-refundable, non-transferable, and are not valid for upgrades. Disney is not liable for any expenses incurred as a consequence of flight cancellation/delay.

- Reservation requirements to enter the *Walt Disney World*® Theme Parks are subject to change.
- Certain parks, hotels, restaurants and other offerings may be modified or unavailable, limited in capacity, and subject to limited availability or closure, and park admission and offerings are not guaranteed.
- Theme parks, attractions and other offerings are subject to availability, closures, change or cancellation without notice or liability. Park admission, offerings and ticket options are not guaranteed.
- To visit the theme parks, theme park reservations via the Disney Park Pass system (<https://disneyworld.disney.go.com/experience-updates/park-reservations/>) AND valid admission are required for the same theme park on the same date for each person in the group, ages 3 and up. Reservations are subject to availability and are not guaranteed until a reservation is finalized. A park reservation must be made for each day of entry.
- The *Park Hopper*® option allows guests to visit more than one park per day, with some restrictions. Learn more at <https://disneyworld.disney.go.com/guest-services/park-hopper/>.
- Prize winner must be at least the age of majority pursuant to his/her applicable state of residence to enter and win. A Guest under the age of majority must be accompanied by his/her parent/legal guardian, who must be at least the age of majority and both will be deemed Guests of the winner (unless the Prize winner is the Guest's parent or legal guardian). Once selected by Prize winner, Guests cannot be changed without the express consent of Disney, which may be withheld for any reason.

- All elements of the Vacation Package must be used by the Group on the same dates during the redemption of the Vacation Package. Any portion of the Vacation Package not accepted or used by winner will be forfeited.
- The Prize winner may not charge any Guest for participating in the prize. Prizes are awarded "as is" with no warranty or guarantee, expressed or implied, being provided by Sponsor or Disney.
- The Prize winner and his/her Guests are responsible for having valid travel documents including government-issued identification and/or passports, as applicable.
- Prize winner is required to have and present a major credit card in good standing upon check-in.
- The Prize winner will not receive compensation for any element(s) of the Vacation Package that any participant(s) is unable to use for any reason, and such unused portion(s) of the Vacation Package will be forfeited.
- If the Prize winner chooses to bring less than the allotted number of Guests, the Vacation Package will be awarded in increments suitable for the actual number of participants with no substitute prize or compensation provided to the winner.

- The Prize winner and his/her Guests will be required to execute a liability/publicity release form prior to booking of any travel. Failure to return the executed release form within the specified time period will result in forfeiture of the Vacation Package. Winner acknowledges that he/she is solely responsible for any actions, claims or liabilities of the Group, related to any use or misuse of the prize or any prize-related activity or travel.
- Any damaged, lost or stolen gift cards or travel vouchers will not be replaced. Gift cards are not redeemable or exchangeable for cash (except as required by law) and are subject to all terms and conditions of use as established by issuer.
- The actual value of the Vacation Package may vary depending on point of departure and seasonal fluctuations of hotel rates and airfares. Any difference between the approximate retail value and the actual cost of the/each Vacation Package will not be awarded.

Sponsor shall not be responsible for any cancellations, delays, diversions or substitutions or any act or omissions whatsoever by the air carriers, hotels and/or other transportation companies or any other persons providing any of these services or accommodations. Sponsor shall not be liable for any loss or damage to baggage.

In the event Prize winner and/or their Guests engage in behavior that (as determined by Sponsor or Disney in their sole discretion) is obnoxious or inappropriate, threatening, illegal or that is intended to annoy, abuse, threaten or harass any other person, Sponsor reserves the right to terminate the applicable experience early, in whole or in part, and send Prize winner and/or Guests home with no further compensation.

Prizes are not redeemable for cash or transferable, except to a surviving spouse residing in the same household. No substitutions allowed except, at Sponsor's sole discretion, a prize, or prize element, of equal or greater value may be substituted. Certain prize items are subject to availability and may be substituted by Sponsor for a different item of greater or equal value, in its sole discretion. Gift card/subscriptions are subject to separate terms and conditions imposed by issuer.

Winner shall be solely responsible for any applicable federal, state, and local taxes and/or local laws and regulations, and the reporting consequences thereof, and for any other fees or costs associated with a Prize. Winner will receive an IRS Form 1099 reflecting the final actual value of any Prize valued at \$600 or more and must submit a validly executed IRS Form W-9 to claim Prize.

VI. **RELEASES.**

By participating, entrants agree to be bound by these Official Rules and the decisions of the Sponsor, which shall be final in all respects.

By participating in this Sweepstakes and accepting any prize that they may win, entrants agree to release Sponsor, Disney, any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Sweepstakes or supplying a prize, each of the foregoing entities' respective parent, subsidiary, affiliated and successor companies, and each of their respective officers, directors, agents, representatives and employees, as well as each of their respective successors, representatives and assigns (collectively, the "**Released Parties**") from any and all actions, claims, injury, loss or damage arising in any manner, directly or indirectly, from participation in this Sweepstakes and/or acceptance or use of the prize.

Winner agrees that the Released Parties have not made nor are in any manner responsible or liable for any warranty, representation or guarantee, express or implied, in fact or in law, relative to any prize.

Entrants authorize the Released Parties to use their name, voice, likeness, biographical data, city and state of residence and entry materials in programming or promotional material, worldwide in perpetuity, or on a winner's list, if applicable, without further compensation unless prohibited by law. Sponsor is not obligated to use any of the above-mentioned information or materials, but may do so and may edit such information or materials, at Sponsor's sole discretion, without further obligation or compensation.

VII. MISCELLANEOUS.

Void where prohibited. All federal, state and local laws and regulations apply. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and/or Released Parties in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of California, without regard for conflicts of law doctrine of California or any other jurisdiction, and all proceedings shall take place in the County of Los Angeles. Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process and to cancel, terminate, modify and/or suspend the Sweepstakes in the event of tampering or other circumstances, including, but not limited to, acts of God or civil disturbance that render it impractical or impossible to complete or fulfill the Sweepstakes as originally planned.
