

# FLORIDA GEORGIA LINE GREATEST HITS ON THE RED CARPET SWEEPSTAKES - OFFICIAL RULES

## I. NAME OF SPONSOR(S)

KABC-TV, ABC Holding Company Inc. (hereinafter referred to as "**Sponsor**").

## II. ELIGIBILITY

The Florida Georgia Line Greatest Hits On The Red Carpet Sweepstakes (the "**Sweepstakes**") is open to legal residents of the fifty (50) United States who are at least eighteen (18) years of age and the age of majority in their state of legal residence at the time of entry.

Any individuals (including, but not limited to, employees, consultants, independent contractors, and interns) who have, within the past six (6) months, performed services for Sponsor, other television and radio stations in the greater Los Angeles area, Instagram, or any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Sweepstakes or supplying a prize, and/or their respective parent, subsidiary, affiliated and successor companies, and immediate family and household members of such individuals, and any person who, within the past ninety (90) days, has been awarded a prize in any sweepstakes conducted by Sponsor, are not eligible to enter or win (subject to the conditions stated below). "Immediate family members" shall mean parents, stepparents, children, stepchildren, siblings, stepsiblings, or spouses. "Household members" shall mean people who share the same residence at least three (3) months a year.

### **NO PURCHASE NECESSARY.**

Starting at 12:01pm Pacific Time ("PT") on **Friday, November 4, 2022** and ending at 11:59pm PT on **Tuesday, November 8, 2022** ("**Entry Period**") you may enter the Sweepstakes by visiting the official On The Red Carpet Instagram page (@OnTheRedCarpet) located at <https://www.instagram.com/ontheredcarpet> ("**On The Red Carpet Instagram**"), and fulfilling the requirements listed below.

To enter the Sweepstakes, you'll first need to become a registered user of [www.instagram.com](http://www.instagram.com) ("**Instagram**") or log into your Instagram account. If you do not have an account, go to [www.instagram.com](http://www.instagram.com) to create one. Instagram accounts are free. By submitting your information and creating an Instagram account, you agree to the Instagram Terms of Use and Privacy Notice. If you do not agree to such Terms of Use and Privacy Notice, you cannot create an Instagram account, or participate in this Sweepstakes. Additionally, to enter, your account must be set to public.

### **TO ENTER THIS SWEEPSTAKES, YOU MUST:**

- (1) "Follow" the On The Red Carpet Instagram account (@OnTheRedCarpet);**
- (2) Find and "Like" the Sweepstakes-themed post on the On The Red Carpet Instagram feed ("Sweepstakes Post"); AND**
- (3) Comment on the Sweepstakes Post by tagging three (3) of your friends who are eligible for the Sweepstakes along with #Sweepstakes (the "Required Hashtag"). Sponsor, in its sole discretion, may disqualify any Entry that is deemed inappropriate, illegal or offensive, or otherwise not considered to be a valid Entry, and entrant will not be eligible to win a Prize (as defined below).

You understand that you are providing your information to Sponsor and not to Instagram, as this Sweepstakes is not sponsored, endorsed or administered by Instagram, nor is Instagram associated with this Sweepstakes in any way. Your Entry via Instagram posting must be created for the sole purpose of this Sweepstakes and must be posted by the entrant. Re-Grams will not be accepted. - Communicates messages or images inconsistent with the positive images and/or good will to which we wish to associate; and/or
- Violates any law.

By submitting an Entry, entrant hereby grants permission for the Entry to be posted on Sponsor's websites and social media platforms. Entrant agrees that Released Parties (as defined below) are not responsible for any unauthorized use of entries by third parties. Released Parties do not guarantee the posting of any entry and may remove any posted entry at any time.

Neither Sponsor nor On The Red Carpet can provide any technical support, and accept no responsibility for ensuring the receipt or successful submission of your Entry. Mass Entries or Entries generated by a script, macro or use of automated methods will be disqualified. Sponsor is not responsible for failed, partial or garbled computer transmissions, or for technical failures of any kind, including, but not limited to, electronic malfunction or damage of any network, hardware or software. If for any reason the Sweepstakes is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or other causes that corrupt or affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes, Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Sweepstakes. #### **IV. HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED**

Winners will be selected on or about 10:00am PT **Monday, November 14, 2022**. One (1) grand prize winner and nine (9) secondary winners will be selected in a random drawing from among all eligible Entries received. Potential winners will be notified on or around the date of selection by Instagram direct message and/or a comment on their Entry.

Odds of winning depend on the total number of valid Entries received. Limit one (1) prize per person and only one (1) person per household can win. In the event the eligible entry pool is less than the amount of prizes available, Sponsor reserves the right, in its sole discretion, to award prizes to all Entries received, including to such entrants who have won a prize from Sponsor within the past ninety (90) days, but who are otherwise eligible.

Final determination of the winners is always conditional on verification of eligibility and compliance with these Official Rules and procedures.

Failure to respond within twenty-four (24) hours after initial notification message to a potential winner or return of the notification as undeliverable after two (2) attempts may result in disqualification and award of the prize to an alternate winner. Potential winners will be required to complete, sign and return within three (3) business days of transmission, an Affidavit of Eligibility, Release and Indemnification, and a Publicity Release where allowed by law, W-9 Form, if applicable and any other documentation required by Sponsor (collectively, "**Verification Documents**"). If potential winners do not respond to the initial notification within twenty-four (24) hours as set forth above, if Verification Documents are not returned to Sponsor within the specified time period, if any prize notification or prize is returned as non-deliverable, if a potential winner is found to be ineligible or otherwise not in compliance with these Official Rules, or if a potential winner cannot or does not accept the prize for any reason, prize may be forfeited and such

In the event of any dispute concerning the identity of any entrant, the Entry will be deemed submitted by the natural person who is the authorized holder of the email address used to create an Instagram account. "Authorized account holder" is defined as the natural person who is assigned to an email address by an Internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

The approximate retail value ("**ARV**") of Grand Prize = **\$186.99**

Nine (9) Secondary Prize winners will receive a prize package including the following (collectively, the "**Secondary Prize**").

- One (1) Florida Georgia Line Greatest Hits CD

The approximate retail value ("**ARV**") of each Secondary Prize = **\$17.99**

Total ARV of all prizes being awarded = **\$348.90**

If the actual value of a prize is less than stated ARV, the difference will not be awarded. Some restrictions may apply.

Federal, state and local taxes, if any, are the sole responsibility of the winner, who will receive an IRS Form 1099 reflecting the final actual value of any prize valued at \$600 or more.

Prize components may not be sold, traded, transferred, or refunded. Prize is not redeemable for cash. No substitution of prize or any elements thereof is allowed, except at the Sponsor's sole discretion. All prizes will be awarded provided a sufficient number of eligible Entries are received.

Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process and to cancel, terminate, modify and/or suspend the Sweepstakes in the event of tampering or other circumstances, including, but not limited to, acts of God or civil disturbance that render it impractical or impossible to complete or fulfill the Sweepstakes as originally planned.
