"JOSS STONE MERRY CHRISTMAS, BABY" ON THE RED CARPET SWEEPSTAKES - OFFICIAL RULES

I. <u>NAME OF SPONSOR(S)</u>

KABC-TV, ABC Holding Company Inc. (hereinafter referred to as "Sponsor").

II. <u>ELIGIBILITY</u>

"Joss Stone Merry Christmas, Baby" On The Red Carpet Sweepstakes (the "**Sweepstakes**") is open to legal residents of the fifty (50) United States who are at least eighteen (18) years of age and the age of majority in their state of legal residence at the time of entry.

Winners will be selected on or about 10:00am PT **Monday, December 19, 2022**. One (1) grand prize winner and nine (9) secondary winners will be selected in a random drawing from among all eligible Entries received. Potential winners will be notified on or around the date of selection by Instagram direct message and/or a comment on their Entry.

Odds of winning depend on the total number of valid Entries received. Limit one (1) prize per person and only one (1) person per household can win.
