

KABC-TV - DISNEY WONDER CRUISE SWEEPSTAKES - OFFICIAL RULES

**NO PURCHASE NECESSARY
VOID WHERE PROHIBITED BY LAW**

I. NAME OF SPONSOR

KABC Television, LLC, licensee of KABC-TV (hereinafter referred to as "**Sponsor**"), 500 Circle Seven Drive, Glendale, CA 91201.

II. ELIGIBILITY

The KABC-TV - Disney Wonder Cruise Sweepstakes (the "**Sweepstakes**") is open only to legal United States residents who reside in the Designated Market Area ("**DMA**") of Sponsor, as determined by Nielsen Media Research Services, and who are at least eighteen (18) years of age or older. The DMA of KABC-TV covers the following counties in the State of California: Inyo, Kern County-East, Los Angeles, Orange, Riverside County-East, Riverside County-West, San Bernardino, and Ventura counties.

Any employees, consultants, and independent contractors of Sponsor, other television and radio stations in the DMA, Magical Cruise Company, Ltd. ("**Disney**"), or any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Sweepstakes or supplying a prize, and/or their respective parent, subsidiary, affiliated and successor companies, and immediate family and household members of such individuals are not eligible to enter or win. "Immediate family members" shall mean parents, stepparents, children, stepchildren, siblings, stepsiblings, or spouses. "Household members" shall mean people who share the same residence at least three (3) months a year.

III. HOW AND WHEN TO ENTER

Viewers should watch Eyewitness News on ABC7 Monday – Friday, starting at 6:00 am Pacific Time ("**PT**") beginning Monday, April 27, 2026 through Friday, May 8, 2026 ("**Sweepstakes Period**"). There will be one (1) new "SECRET CODE" that appears during each morning's 6:00 am PT broadcast. Check local listings.

Once you have the Secret Code, each weekday (Monday – Friday only) during the Sweepstakes Period, from 6:00 am PT to 11:59 am PT (each, an "**Entry Period**") you may enter the "SECRET CODE" corresponding to that day by navigating the Internet to <http://www.abc7.com/promotions> ("**Website**"), clicking on the Sweepstakes-themed image and then clicking on the link to the Sweepstakes entry form. To submit an official Sweepstakes entry, complete the Sweepstakes entry form and enter the correct "SECRET CODE".

CLICK THE CHECK BOX SIGNIFYING THAT YOU HAVE READ AND AGREE TO THESE OFFICIAL RULES. IF YOU DO NOT CHECK THE BOX INDICATING YOUR CONFIRMATION OF AND AGREEMENT TO THE ABOVE, YOU WILL NOT BE ENTERED IN THE SWEEPSTAKES AND CANNOT WIN THE PRIZE.

Entrants will receive one (1) entry into the Sweepstakes drawing with the submission of a correctly-spelled "SECRET CODE" by the end of the corresponding Entry Period. For example, if hypothetically the "SECRET CODE" on April 27, 2026 is "cat", the entrant has to submit "cat" (correctly spelled) by 11:59 am PT on April 27, 2026 (capitalization need not be exact, but Secret Code must be spelled correctly).

Limit one (1) Sweepstakes entry via the method listed above (each an "**Entry**" and collectively referred to herein as "**Entries**") per person for each Entry Period, regardless of how many Member accounts a person may have (as further described below). Entries remain the property of Sponsor and will not be returned or acknowledged.

To enter the Sweepstakes, you must be a registered member of One-ID ("**Member**").

Existing Member: As a Member, you may enter the Sweepstakes by logging into the Website with your user name or email address and password and following the entry instructions. If you login to your Member account using Facebook, you will be asked to allow Facebook's "Basic App Permissions," which is required in order to login to your Member account and participate in the Sweepstakes.

Non-Member: If you are not a Member, you may become a Member free of charge by visiting the Website and registering by providing the requested information on the registration form through the “sign up” or similar section on the Website. By creating a Member account, you acknowledge your agreement to the Terms of Use (available at <http://disneytermsofuse.com>). Upon becoming a Member and meeting eligibility requirements, you may enter the Sweepstakes by following the instructions.

By clicking the “Continue” button to continue with your Entry (as described below), you confirm that you meet the eligibility requirements of this Sweepstakes and agree to these Sweepstakes Official Rules. During the registration and entry process, you may be asked to consent to receive promotional and marketing emails from Sponsor, ABC Television Network and/or other members of the Walt Disney family of companies or the prize provider. Consenting to receive promotional, marketing or reminder emails is optional, does not have to be agreed to in order to be eligible to enter the Sweepstakes and does not improve your chances of winning. In the event you do consent to receive these emails, the use of such emails shall be subject to the privacy policy of the entity requesting your optional consent.

Sponsor can provide no technical support and accepts no responsibility for ensuring the receipt or successful submission of your Entry. Mass Entries or Entries generated by a script, macro or use of automated methods will be disqualified. Sponsor is not responsible for failed, partial or garbled computer transmissions, or for technical failures of any kind, including, but not limited to, electronic malfunction or damage of any network, hardware or software. If for any reason the Sweepstakes is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, human error, or other causes that corrupt or affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes, Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Sweepstakes. No responsibility is assumed for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, Entries; or any problems or technical malfunctions of any telephone network or lines, computer online systems, servers, or providers, computer equipment, software, failure of any email or electronic Entry to be received on account of technical problems or traffic congestion on the Internet or Website, or any combination thereof, including any injury or damage to entrant’s or any other person’s computer related to or resulting from participation in or downloading any materials from this Sweepstakes. Except as otherwise contemplated by these Official Rules, and to the extent entrants may otherwise elect at the time of Entry, information provided by you for these Sweepstakes is subject to Sponsor’s privacy policy. THE WEBSITE, LINKS, BANNERS, PREDICTION MECHANISMS, AND/OR THE ENTRY FORM MAY NOT BE ACCESSIBLE FROM ALL MOBILE PHONES, HANDHELD DEVICES, AND/OR TABLETS. IF AN ENTRANT EXPERIENCES ANY ISSUES ENTERING, THEY SHOULD ACCESS THE WEBSITE AND ENTER FROM A DESKTOP OR LAPTOP COMPUTER.

IV. HOW AND WHEN WINNER WILL BE SELECTED AND NOTIFIED

One (1) potential winner will be selected via a random drawing from among all eligible Entries received during the Entry Period on or about **May 11, 2026**. Potential winner will be notified on or around the date of selection by telephone or email at the email address or phone number listed in their Member account profiles. Odds of winning depend on the total number of valid Entries received during the Entry Period.

Final determination of the winner is always conditional on verification of eligibility and compliance with these Official Rules and procedures. Failure to respond to the initial verification phone call and/or email within forty-eight (48) hours after initial notification to the potential winner or return of the email notification as undeliverable after two (2) attempts may result in disqualification and award of the prize to an alternate winner. Potential winner will be required to complete, sign and return within two (2) business days of transmission, an Affidavit of Eligibility, Release and Indemnification, and a Publicity Release where allowed by law, W-9 Form, if applicable and any other documentation required by Sponsor (collectively, “**Verification Documents**”). If a potential winner does not respond to the initial notification within forty-eight (48) hours as set forth above, if Verification Documents are not returned to Sponsor within the specified time period, if potential winner cannot attend any programming connected with the Sweepstakes on the specified date, if any prize notification or prize is returned as non-deliverable, if potential winner is found to be ineligible or otherwise not in compliance with these Official Rules, or if potential winner cannot or does not accept the prize for any reason, prize may be forfeited and potential winner may be disqualified without compensation of any kind and an alternate winner may be selected in a random drawing (time permitting) from remaining eligible entries received.

In the event of any dispute concerning the identity of any entrant, the Entry will be deemed submitted by the natural person who is the authorized holder of the email listed in the Member account. “Authorized account holder” is defined as the natural person who is assigned to an email address by an Internet access provider, online service provider, or other organization

(e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

V. PRIZE

One (1) prize (“**Prize**”) is available. The Prize consists of a Disney Cruise Line vacation package for winner and up to three (3) persons to be taken aboard the Disney Wonder (“**Vacation Package**”) that consists of the following:

- One (1) standard room with a maximum occupancy of four (4) persons at a hotel in San Diego, California (hotel selection at the discretion of Sponsor) for one (1) night prior to the ship’s departure.
- Parking for one (1) vehicle at a hotel near the Port of San Diego while aboard the ship (at the discretion of Sponsor).
- One (1) four (4)-night cruise on the Disney Wonder for up to three (3) persons, consisting of:
 - One (1) stateroom aboard the Disney Treasure (location/category at the discretion of Sponsor) with a maximum occupancy four (4) people;
 - All meals onboard the Disney Wonder (excluding specialty and fine dining);
 - Pre-paid onboard gratuities for the stateroom host/hostess, dining room server, assistant server, and head server;
 - Taxes, Fees, and Port Expenses (as defined on the Disney Cruise Line website).

ARV of the Prize is \$5,950.84 which includes Taxes, Fees, and Port Expenses (as defined on the Disney Cruise Line website). The actual value of the Vacation Package may vary depending on point of departure and fluctuations of rates (if applicable). If the actual value of the Vacation Package is less than stated ARV, the difference will not be awarded.

The Vacation Package is subject to the conditions set forth below.

All costs and expenses not expressly stated in the Vacation Package description above are excluded and solely the responsibility of winner or guests, including but not limited to:

- Shore excursions
- Travel insurance
- Laundry service
- Spa treatments
- Alcoholic and specialty non-alcoholic beverages (including specialty coffee)
- Individually charged snacks and treats (including but not limited to movie popcorn,
- packaged candy, ice cream, gelato, pastries, and bar snacks)
- Local and long distance telephone calls
- Ship to shore communications including internet
- Merchandise and souvenirs
- Tips and gratuities not specifically set forth above

Additional Prize Restrictions:

Travel for the Vacation Package must be booked at least forty-five (45) days prior to the intended travel dates and must occur from **June 14, 2026 to June 14, 2027**. If travel is not completed by **June 14, 2027** the prize will be forfeited without compensation of any kind. No changes will be made to travel details once any element(s) of the travel arrangements have been booked except in Sponsor’s sole discretion. Block-out dates may apply. Vacation dates and accommodations are subject to availability; certain restrictions and block-out dates may apply. Sponsor reserves the right to change the allowable travel dates, cruise ship or any other component of the Vacation Package, for any reason and in its sole discretion. No substitution of Vacation Package or any elements thereof is allowed, except at Sponsor’s sole discretion. Ports of call, offerings and experiences onboard are subject to change, availability and cancellation without notice.

Block Out Dates: December 18, 2026

(Block Out Dates at the discretion of Disney Cruise Line and subject to change)

Vacation Package components may not be sold, traded, transferred, or refunded. Vacation Package is not redeemable for cash. Vacation Package is non-commissionable.

Vacation is for the winner and up to three (3) guest(s) of the winner’s choosing. Once selected by the winner, guests cannot be changed without the express consent of Sponsor, which may be withheld for any reason. If the winner chooses to bring less than the allotted number of guests, the Vacation Package will be awarded in increments suitable for the actual number of participants with no substitute Vacation Package or compensation provided to the winner.

If Vacation Package includes airfare, the winner and guests must travel together on the same itinerary, and air transportation must be round-trip from/to the departure airport (with possible layovers). Sponsor will determine airline and flight itinerary in

its sole discretion. Airline carrier's regulations and conditions apply to air travel. Airline tickets are nonrefundable, non-transferable, and are not valid for upgrades.

Actual value of the prize awarded depends on a number of factors, including booking and travel dates and the number of travelers, and therefore may be lower or higher than the estimated value at the time it is fulfilled. If the actual value of the prize is less than the stated estimated value, the difference will not be awarded. The winner will not receive compensation for any element(s) of the Vacation Package that any participant(s) is unable to use for any reason, and such unused portion(s) of the Vacation Package will be forfeited.

No refund or compensation will be made in the event of the cancellation or delay of any flight or cruise (as applicable). Sponsor is not liable, including for any costs or expenses, if any component of the Vacation Package is delayed, postponed or cancelled for any reason and winner will not be reimbursed, and no substitution will be provided except as in Sponsor's sole discretion.

If Vacation Package includes hotel stay, photo identification and credit card in good standing or cash deposit may be required at check-in for incidental charges (e.g., room service, use of telephone/IT services, laundry and all other optional extra services not provided in the prize).

The winner and guests are responsible for providing proper citizenship documentation to travel which may include passports, valid alien registration card and/or necessary visas. Those without proper citizenship documentation will be denied boarding. The winner and each guest are responsible for ensuring that they have proper citizenship documentation.

The winner and each guest will be required to execute a liability/publicity release and waiver form prior to booking of any travel. The winner and each guest will also be required to sign the Disney Cruise Line cruise contract before embarkation (the "**Cruise Contract**"). The Cruise Contract is available at www.disneycruise.com/cruisecontract. Failure to return the executed release form or to accept and sign the Cruise Contract within the specified time periods will result in forfeiture of the Vacation Package. Winner acknowledges that he/she is solely responsible for any actions, claims or liabilities of their travel party, related to any use or misuse of the Vacation Package or any related activity or travel.

Health and safety measures and operational guidelines, ports of call and offerings may change at any time without notice. Certain onboard venues, experiences and other offerings may be modified or unavailable, will have limited capacity and will be subject to limited availability, advance reservations or even closure.

In the event the winner and/or guest(s) engage in behavior that, as determined by Sponsor in its sole discretion, is obnoxious or threatening, illegal, is intended to annoy, abuse, threaten or harass any other person, or is contrary to Sponsor's health and safety protocols, rules or policies in effect at the time of the Vacation Package, Sponsor reserves the right to terminate the Vacation Package or other applicable experience early, in whole or in part, and send the winner and/or guest(s) home with no further compensation. The winner acknowledges and agrees to be solely responsible for any actions, claims or liabilities of any member of the group.

Minors under the age of eighteen (18) not traveling with a parent or legal guardian must be accompanied by an adult over the age of twenty-one (21) in the same stateroom. The parent or guardian of any minor not traveling with a parent or guardian must appoint an adult to have custody and control over their minor and to contract on their behalf in connection with the Vacation Package. An appointment form will be included in the document package and must be signed by parent or legal guardian prior to embarkation at the Disney Cruise Line terminal.

Vacation Package is awarded "as is" with no warranty or guarantee, expressed or implied, being provided by Sponsor.

Vacation Package fulfillment is subject to restrictions. Failure to accept the Vacation Package within the indicated time period may result in forfeiture.

Federal, state and local taxes, if any, are the sole responsibility of the winner, who will receive an IRS Form 1099 reflecting the final actual value of the prize.

VI. RELEASES

The Sweepstakes is governed by all applicable federal, state and local laws, and by these Official Rules. By participating, entrants agree to be bound by these Official Rules and the decisions of the Sponsor, which shall be final in all respects.

By participating in this Sweepstakes and accepting any prize that they may win, entrants agree to release Sponsor, Disney, each of their respective parent, subsidiary, affiliated and successor companies, advertising and promotion agencies and prize suppliers, and each of their respective officers, directors, agents, representatives and employees, as well as each of their respective successors, representatives and assigns (collectively, the "**Released Parties**") from any and all actions, claims, injury, loss or damage arising in any manner, directly or indirectly, from participation in this Sweepstakes and/or acceptance or use of the prize, including, but not limited to, potential exposure to COVID-19.

The Prize winner agrees that the Released Parties have not made nor are in any manner responsible or liable for any warranty, representation or guarantee, express or implied, in fact or in law, relative to any prize.

Entrants authorize the Released Parties to use their name, voice, likeness, biographical data, city and state of residence and entry materials in programming or promotional material, worldwide in perpetuity, or on a winner's list, if applicable, without further compensation unless prohibited by law. Sponsor is not obligated to use any of the above-mentioned information or materials, but may do so and may edit such information or materials, at Sponsor's sole discretion, without further obligation or compensation.

VII. MISCELLANEOUS; WINNER'S LIST

Void where prohibited. All federal, state and local laws and regulations apply.

Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process and to cancel, terminate, modify and/or suspend the Sweepstakes in the event of tampering or other circumstances, including, but not limited to, acts of God or civil disturbance that render it impractical or impossible to complete or fulfill the Sweepstakes as originally planned.
