#### "LET IT BRO" SWEATER SWEEPSTAKES

#### **OFFICIAL RULES**

#### NO PURCHASE NECESSARY.

### I. NAME OF SPONSOR(S)

KABC Television, LLC, licensee of KABC-TV (hereinafter referred to as "**Sponsor**"), 500 Circle Seven Drive, Glendale, CA 91201.

### II. ELIGIBILITY

"Let It Bro" Sweater Sweepstakes (the "Sweepstakes") is open to legal residents of the fifty (50) United States and the District of Columbia who are eighteen (18) years of age or older at the time of entry.

### IV. HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED

At the conclusion of the Entry Period, fifty (50) potential winners will be selected in a random drawing from among all eligible Entries received. Potential winners will be notified on or around the date of selection by Instagram direct message and/or a comment on their Entry.

Odds of winning depend on the total number of valid Entries received. Limit one (1) prize per person and only one (1) person per household can win.
