"MOANA 2" ON THE RED CARPET SWEEPSTAKES - OFFICIAL RULES

I. NAME OF SPONSOR(S)

KABC-TV, ABC Holding Company Inc. (hereinafter referred to as "**Sponsor**"), 500 Circle Seven Drive, Glendale, CA 91201.

II. ELIGIBILITY

One (1) potential winner will be selected in a random drawing from among all eligible Entries received on or about **December 10, 2024**. Potential winner will be notified on or around the date of selection by Instagram direct message and/or a comment on their Entry.

Odds of winning depend on the total number of valid Entries received. Limit one (1) prize per person and only one (1) person per household can win.

Final determination of the winner is always conditional on verification of eligibility and compliance with these Official Rules and procedures.

Failure to respond within twenty-four (24) hours after initial notification message to a potential winner or return of the notification as undeliverable after two (2) attempts may result in disqualification and award of the prize to an alternate winner.
