

KABC-TV "HALLOWEEN TIME AT THE DISNEYLAND® RESORT" SWEEPSTAKES - OFFICIAL RULES

NO PURCHASE NECESSARY

I. NAME OF SPONSOR(S)

KABC Television, LLC, licensee of KABC-TV (hereinafter referred to as "**Sponsor**"), 500 Circle Seven Drive, Glendale, CA 91201.

II. ELIGIBILITY

The KABC-TV "Halloween Time at the Disneyland Resort" Sweepstakes (the "**Sweepstakes**") is open only to legal United States residents who reside in the Designated Market Area ("**DMA**") of KABC-TV, as determined by Nielsen Media Research Services, and who are at least eighteen (18) years of age or older. The DMA of KABC-TV covers the following counties: Inyo, Kern County-East, Los Angeles, Orange, Riverside County-East, Riverside County-West, San Bernardino, and Ventura counties in the State of California.

Any individuals (including, but not limited to, employees, consultants, independent contractors, and interns) who have, within the past six (6) months, performed services for Sponsor, other television and radio stations in the DMA, Disney Destinations, LLC ("**Prize Provider**"), or any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Sweepstakes or supplying a prize, and/or their respective parent, subsidiary, affiliated and successor companies, and immediate family and household members of such individuals, and any person who, within the past ninety (90) days, has been awarded a prize in any sweepstakes conducted by Sponsor, are not eligible to enter or win. "Immediate family members" shall mean parents, stepparents, children, stepchildren, siblings, stepsiblings, or spouses. "Household members" shall mean people who share the same residence at least three (3) months a year. This Sweepstakes is not sponsored or administered by Prize Provider.

III. HOW AND WHEN TO ENTER

Viewers should watch Eyewitness News on ABC7 Monday – Friday, starting at 6:00 am Pacific Time ("**PT**") beginning **Monday, September 21, 2026** through **Friday, October 2, 2026** ("**Sweepstakes Period**"). There will be one (1) new "SECRET CODE" that appears during each morning's 6:00 am PT broadcast. Check local listings.

Once you have the Secret Code, each weekday (Monday – Friday only) during the Sweepstakes Period, from 6:00 am PT to 11:59 am PT (each, an "**Entry Period**") you may enter the "SECRET CODE" corresponding to that day by navigating the Internet to <http://www.abc7.com/promotions> ("**Website**"), clicking on the Sweepstakes-themed image and then clicking on the link to the Sweepstakes entry form. To submit an official Sweepstakes entry, complete the Sweepstakes entry form and enter the correct "SECRET CODE".

Entrants will receive one (1) entry into the Sweepstakes drawing with the submission of a correctly-spelled "SECRET CODE" by the end of the corresponding Entry Period. For example, if hypothetically the "SECRET CODE" on September 21, 2026 is "cat" the entrant has to submit "cat" (correctly spelled) by 11:59 am PT on September 21, 2026 (capitalization need not be exact, but Secret Code must be spelled correctly).

Limit one (1) Sweepstakes entry via the method listed above (each an "**Entry**" and collectively referred to herein as "**Entries**") per person for each Entry Period, regardless of how many Member accounts a person may have (as further described below). Entries remain the property of Sponsor and will not be returned or acknowledged.

To enter the Sweepstakes, complete the entry form by providing your contact information and verifying your zip code within the DMA.

CLICK THE CHECK BOXES CONFIRMING THAT YOU HAVE READ AND AGREE TO: (i) SPONSOR'S TERMS OF USE (available at www.disneytermsofuse.com); (ii) THESE OFFICIAL RULES; and (iii) MEET THE SWEEPSTAKES ELIGIBILITY REQUIREMENTS. IF YOU DO NOT CHECK THE BOXES INDICATING YOUR CONFIRMATION OF AND AGREEMENT TO THE ABOVE, YOU WILL NOT BE ENTERED IN THE SWEEPSTAKES AND CANNOT WIN THE PRIZE.

By clicking the "Continue" button to continue with your Entry (as described below), you confirm that you meet the eligibility requirements of this Sweepstakes and agree to these Sweepstakes Official Rules. During the entry process, you may be asked to consent to receive promotional and marketing emails from ABC and/or other members of the Walt Disney family of companies or the prize provider. If for any reason the Sweepstakes is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or other causes that corrupt or affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes, Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Sweepstakes. No responsibility is assumed for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, Entries; or any problems or technical malfunctions of any telephone network or lines, computer online systems, servers, or providers, computer equipment, software, failure of any email or electronic Entry to be received on account of technical problems or traffic congestion on the Internet or Website, or any combination thereof, including any injury or damage to entrant's or any other person's computer related to or resulting from participation in or downloading any materials from this Sweepstakes. Except as otherwise contemplated by these Official Rules, and to the extent entrants may otherwise elect at the time of Entry, information provided by you for these Sweepstakes is subject to Sponsor's privacy policy.

IV. HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED

Two (2) potential winners will be selected in a random drawing each weekday during the first week of the Sweepstakes Period (9/21/26-9/25/26) and three (3) potential winners will be selected in a random drawing each weekday during the second week of the Sweepstakes Period (9/28/26-10/2/26) with the exception of the final day of the Sweepstakes Period (10/2/26), which will have four (4) potential winners selected. Potential winners will be selected from among all eligible entries received during the corresponding Entry Period, for a total of twenty-six (26) winners throughout the Sweepstakes Period. Non-winning entries WILL NOT roll over to subsequent drawings, if any. Potential winners may be announced on air following each drawing during the 6:00 am PT morning news. **Odds of winning a Prize depend on the total number of valid Entries received during the corresponding Entry Period.**

Limit one (1) prize per person and only one (1) person per household can win.

Final determination of the winners is always conditional on verification of eligibility and compliance with these Official Rules and procedures. Potential winners will be notified by telephone and/or e-mail, using contact information associated with their Member account. Failure to respond to the initial verification phone call and/or email within twenty-four (24) hours after initial notification to the potential winner or return of the email notification as undeliverable after two (2) attempts may result in disqualification and award of the prize to an alternate winner. Potential winners will be required to complete, sign and return within one (1) business day of transmission, an Affidavit of Eligibility, Release and Indemnification, and a Publicity Release where allowed by law, W-9 Form, and any other documentation required by Sponsor (collectively, "**Verification Documents**"). If a potential winner does not respond to the initial notification within twenty-four (24) hours as set forth above, if Verification Documents are not returned to Sponsor within the specified time period, if any prize notification or prize is returned as non-deliverable, if potential winner is found to be ineligible or otherwise not in compliance with these Official Rules, or if potential winner cannot or does not accept the prize for any reason, prize may be forfeited and potential winners may be disqualified without compensation of any kind and an alternate winner may be selected in a random drawing (time permitting) from remaining eligible entries received.

In the event of any dispute concerning the identity of any entrant, the Entry will be deemed submitted by the natural person who is the authorized holder of the email listed in the Member account. "Authorized account holder" is defined as the natural person who is assigned to an email address by an Internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

V. PRIZES

Twenty-six (26) prizes (each, a “**Prize**”) are available, one (1) grand prize (“**Grand Prize**”) and twenty-five (25) secondary prizes (each, a “**Secondary Prize**”).

Grand Prize

The Grand Prize consists of two (2) Inspire Magic Key pass certificates good for:

- Unlimited admission to either *Disneyland*® Park or *Disney California Adventure*® Park
- Standard theme park parking at Mickey & Friends Parking Structure, Pixar Pals Parking Structure or Toy Story Parking Area
- Unlimited digital downloads of Disney PhotoPass photos
- Fifteen percent (15%) off at select dining locations in *Disneyland*® Park and *Disney California Adventure*® Park
- Twenty percent (20%) off at select shopping locations in *Disneyland*® Park and *Disney California Adventure*® Park
- Twenty-five percent (25%) off the purchase of a Lightning Lane Multi Pass

All Inspire Magic Key privileges are subject to change. Grand Prize winner should check the Magic Key Terms and Conditions (Disneyland.com/MagicKeyTerms) for any applicable updates.

The approximate retail value (“**ARV**”) of the Grand Prize is **\$3,698**.

Secondary Prize

Each Secondary Prize consists of four (4) 1-Day, 1-Park per day *Disneyland*® Resort tickets good for admission to either *Disneyland*® Park or *Disney California Adventure*® Park, but not to both Parks on the same day (subject to restrictions). Both a theme park ticket and separate theme park reservation for the same park on the same date are required for park entry for the winner and each guest. Theme park reservations and tickets will be required for each day of the visit and must be obtained before visiting.

The ARV of each Secondary Prize is **\$896**.

Tickets and Inspire Magic Key Passes must be used by September 15, 2027. Federal, state and local taxes, if any, are the sole responsibility of the winner, who will receive an IRS Form 1099 reflecting the final actual value of any prize valued at \$600 or more.

The Inspire Magic Key pass certificate is valid for one (1) Inspire Key pass and must be redeemed by the Winner at a *Disneyland*® Resort ticket booth during normal park operating hours by September 15, 2027. Winner must present a government-issued photo ID for redemption, and all passes must be assigned to eligible individuals at the time of certificate redemption. One (1) Magic Key pass must be assigned to the Winner, and passes may not be reassigned or transferred at any time. No substitutions. Failure, for any reason, to redeem the certificate for any passes or less passes than the certificate maximum will result in forfeiture of such passes. Subject to the Magic Key Terms and Conditions (Disneyland.com/MagicKeyTerms), a pass will be valid for reservation-based park entry and applicable privileges for one (1) year from the date of use of the pass for first entry into a *Disneyland*® Resort

Disneyland® Resort theme park or use of the parking benefit on the pass for the first entry into a pay-on-entry lot at the *Disneyland*® Resort sort, which shall be the same date as the redemption of the Inspire Magic Key pass certificate and assignment of the passes. Pass privileges will not be available until such pass is activated via park entry or applicable entry into a pay-on-entry lot; provided, however, that park reservations, as available and subject to associated restrictions, may be made in anticipation of activation of a pass so long as such pass has not expired. A pass will expire within one (1) year from the date of prize redemption and pass assignment, and upon expiration, such expired pass may no longer be activated or have park reservations scheduled for it, and any existing park reservations for such pass will be cancelled.
