

**ON THE RED CARPET HANNAH MONTANA VINYL SWEEPSTAKES
OFFICIAL RULES**

**NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES
OF WINNING.**

- I. **NAME OF SPONSOR.** KABC Television, LLC, licensee of KABC-TV (hereinafter referred to as “**Sponsor**”), 500 Circle Seven Drive, Glendale, CA 91201.
- II. **ELIGIBILITY.** The On The Red Vinyl Guitar Sweepstakes (the “**Sweepstakes**”) is open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years of age and the age of majority in their state of legal residence, whichever is older, at the time of entry.

Any individuals (including, but not limited to, employees, consultants, independent contractors, and interns) who have, within the past six (6) months, performed services for Sponsor or any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Sweepstakes or supplying a prize, and/or their respective parent, subsidiary, affiliated and successor companies, and immediate family and household members of such individuals, and any person who, within the past ninety (90) days, has been awarded a prize in any sweepstakes conducted by Sponsor, are not eligible to enter or win. "Immediate family members" shall mean parents, stepparents, children, stepchildren, siblings, stepsiblings, or spouses. "Household members" shall mean people who share the same residence at least three (3) months a year.

HOW AND WHEN TO ENTER. Starting on Monday, March 16 at 12:00 p.m. (noon) Pacific Time (“**PT**”) and ending on Sunday, March 22, 2026 at 11:59 a.m. PT (“**Entry Period**”), you may enter the Sweepstakes by visiting the official On The Red Carpet Instagram page (@OnTheRedCarpet) located at <https://www.instagram.com/ontheredcarpet> (“On The Red Carpet Instagram”), and fulfilling the requirements listed below.

To enter the Sweepstakes, you'll first need to become a registered user of www.instagram.com (“Instagram”) or log into your Instagram account. If you do not have an account, go to www.instagram.com to create one. Instagram accounts are free. By submitting your information and creating an Instagram account, you agree to the Instagram Terms of Use and Privacy Notice. If you do not agree to such Terms of Use and Privacy Notice, you cannot create an Instagram account, or participate in this Sweepstakes. Additionally, to enter, your account must be set to public.

TO ENTER THIS SWEEPSTAKES, YOU MUST:

- (1) “Follow” the On The Red Carpet Instagram account (@OnTheRedCarpet);
- (2) Find and “Like” the Sweepstakes-themed post on @OnTheRedCarpet Instagram feed (“Sweepstakes Post”); AND

(3) Comment on the Sweepstakes Post along with #OntheRedCarpet_Sweepstakes (the "Required Hashtag"). All comments must be posted from a non-private social media account and MUST include the Required Hashtag to be eligible as an entry into the Sweepstakes.

A properly-submitted comment to the Sweepstakes Post during the Entry Period from followers of the On The Red Carpet Instagram account, including a "Like" for the Sweepstakes Post, your response to the call-to-action, and the Required Hashtag shall constitute a valid "Entry" into the Sweepstakes. For purposes of these Official Rules, all times and days are Pacific Time. Sponsor's computer is the official time-keeping device for the Sweepstakes.

Limit one (1) Entry per person during the Entry Period, regardless of the number of Instagram accounts a person may have. Multiple Entries in excess of this limitation may result in disqualification of all Entries by such person. Sponsor, in its sole discretion, may disqualify any Entry that is deemed inappropriate, illegal or offensive, or otherwise not considered to be a valid Entry, and entrant will not be eligible to win a Prize (as defined below).

You understand that you are providing your information to Sponsor and not to Instagram, as this Sweepstakes is not sponsored, endorsed or administered by Instagram, nor is Instagram associated with this Sweepstakes in any way. Any questions, comments or complaints regarding this Sweepstakes must be directed to the Sponsor, and not to Instagram. Your Entry via Instagram posting must be created for the sole purpose of this Sweepstakes and must be posted by the entrant. Re-Grams will not be accepted. Entries must be submitted in compliance with the format set forth by Sponsor and any other requirements set forth by Instagram.

- Contains copyrighted materials owned by others (including photographs, sculptures, paintings, and other works of art or images published on or in websites, television, movies or other media), without permission.
- Contains materials embodying the names, likenesses, voices, or other indicia identifying any person, including, without limitation, celebrities and/or other public or private figures, living or dead, without permission.
- Contains look-alikes of celebrities or other public or private figures, living or dead.
- Communicates messages or images inconsistent with the positive images and/or good will to which we wish to associate; and/or
- Violates any law.

By submitting an Entry, entrant hereby grants permission for the Entry to be posted on Sponsor's websites and social media platforms. Entrant agrees that Released Parties (as defined below) are not responsible for any unauthorized use of entries by third parties. Released Parties do not guarantee the posting of any entry and may remove any posted entry at any time.

Neither Sponsor nor On The Red Carpet can provide any technical support, and accept no responsibility for ensuring the receipt or successful submission of your Entry. Mass Entries or Entries generated by a script, macro or use of automated methods will be disqualified. Sponsor is not responsible for failed, partial or garbled computer transmissions, or for technical failures of any kind, including, but not limited to, electronic malfunction or damage of any network, hardware or software. If for any reason the Sweepstakes is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or other causes that corrupt or affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes, Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Sweepstakes. No responsibility is assumed for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, Entries; or any problems or technical malfunctions of any telephone network or lines, computer online systems, servers, or providers, computer equipment, software, failure of any email or electronic Entry to be received on account of technical problems or traffic congestion on the Internet or at any website, or any combination thereof, including any injury or damage to entrant's or any other person's computer related to or resulting from participation in or downloading any materials from this Sweepstakes. Except as otherwise contemplated by these Official Rules, and to the extent entrants may otherwise elect at the time of Entry, information provided by you for these Sweepstakes is subject to Sponsor's privacy policy located at <http://disneyprivacycenter.com/>.

- IV. **HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED.** On or about Monday, March 23, 2026, potential winners will be selected via a random drawing from among all eligible entries received. Potential winners will be notified on or around the date of selection by telephone or email at the email address or phone number listed in their Member account profiles. **Odds of winning depend on the total number of valid Entries received.**

Final determination of the winner is always conditional on verification of eligibility and compliance with these Official Rules and procedures. Failure to respond within forty-eight (48) hours after initial notification message to a potential winner or return of the notification as undeliverable after two (2) attempts may result in disqualification and award of the prize to an alternate winner. Potential winner will be required to complete, sign and return within three (3) business days of transmission, an Affidavit of Eligibility, Release and Indemnification, and a Publicity Release where allowed by law, W-9 Form, if applicable and any other documentation required by Sponsor (collectively, "**Verification Documents**"). If potential winner does not respond to the initial notification within forty-eight (48) hours as set forth above, if Verification Documents are not returned to Sponsor within the specified time period, if the potential winner cannot attend any travel dates connected with the Sweepstakes on the specified date (if applicable), if any prize notification or prize is returned as non-deliverable, if a potential winner is found to be ineligible or otherwise not in compliance with these Official Rules, or if a potential winner cannot or does not accept the prize for any reason, prize may be forfeited and such potential winner may be disqualified without compensation of any kind and an alternate winner may be selected in a random drawing (time permitting) from remaining eligible Entries received.

In the event of any dispute concerning the identity of any entrant, the Entry will be deemed submitted by the natural person who is the authorized holder of the email listed in the Member account. "Authorized account holder" is defined as the natural person who is assigned to an email address by an Internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

- v. **PRIZES.** Seven (7) Grand Prizes are available.

The approximate retail value ("**ARV**") of the Grand Prize is \$121.96.

Prizes are not redeemable for cash or transferable. No substitutions allowed except, at Sponsor's sole discretion, a prize, or prize element, of equal or greater value may be substituted. Certain prize items are subject to availability and may be substituted by

Sponsor for a different item of greater or equal value, in its sole discretion. Gift cards subject to the terms provided by the issuer thereon.

with, the laws of the State of California, without regard for conflicts of law doctrine of California or any other jurisdiction, and all proceedings shall take place in the County of Los Angeles. Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process and to cancel, terminate, modify and/or suspend the Sweepstakes in the event of tampering or other circumstances, including, but not limited to, acts of God or civil disturbance that render it impractical or impossible to complete or fulfill the Sweepstakes as originally planned.
