#### THE BANSHEES OF INISHERIN PRIZE PACKAGE ON THE RED CARPET SWEEPSTAKES - OFFICIAL RULES

### I. NAME OF SPONSOR

Potential winners will be notified on or around the date of selection by Instagram direct message and/or a comment on their Entry.

Odds of winning depend on the total number of valid Entries received.

Final determination of the winners is always conditional on verification of eligibility and compliance with these Official Rules and procedures.

Failure to respond within twenty-four (24) hours after initial notification message or return of the notification as undeliverable after two (2) attempts may result in disqualification and award of the prize to an alternate winner.
